PROCEEDINGS:

Vice Chairman Scot Gring called the meeting to order at 9:02 a.m.

1. CONSIDERATION OF AUGUST 10, 2016 LICENSING COMMITTEE MINUTES

A motion was made by Johnny Johnson to **APPROVE** the August 10, 2016 Licensing Committee Minutes as written, seconded by Richard Gillit; the motion carried unanimously.

2. **COMPLAINTS**

a) A complaint has been brought against Daniel Reynolds, licensee for Reynolds Construction, by William and Coretta Bradley for pulling a permit at 1930 Doherty Road, Colorado Springs, Colorado, for an unlicensed contractor, in violation of Sections RBC201.11.3, No. 1 and RBC201.11.3, No. 3, 2011 Pikes Peak Regional Building Code; and a complaint by Regional Building for allowing occupancy of a residence prior to Temporary Certificate of Occupancy or Certificate of Occupancy at 302 North Dinner Bell Drive and 334 North Dinner Bell Drive, Calhan, Colorado, in violation of Sections RBC110.1 and RBC201.11.3, No. 1, 2011 Pikes Peak Regional Building Code.

All parties testifying were sworn in. Coretta Bradley appeared by telephone and gave the details of her complaint. She stated her contract was with Ridgeline Roofing and Restoration Company to replace the roof on her home in Colorado Springs. She stated this was an insurance claim, and Dean McSwain, the contractor, stated he would replace

the roof for whatever the insurance company was willing to pay. Mrs. Bradley stated she did some research and discovered that Mr. McSwain had not pulled the permit, but had another contractor, Reynolds Construction, pull the permit for her reroofing project.

Daniel Reynolds stated he is a partner with Ridgeline Roofing, and that is the reason that he pulled a permit for this project. Scot Gring pointed out to Mr. Reynolds that he cannot use his license to pull permits for two different companies, and Mr. Reynold stated he was not aware that it is against Code to pull permits for another company. A motion was made by Richard Gillit to place a 90-Day Incident Report in the contractor file for Reynolds Construction, with the stipulation that either Ridgeline Roofing obtains a roofing license, or Mr. Reynolds combines the two companies, i.e. Reynolds Construction and Ridgeline Roofing and Restoration Company, with the State of Colorado within the next 90 days; if completed within 90 days, the Incident Report will be removed from Mr. Reynold's contractor file, and if not completed, Mr. Reynolds must reappear in 90 days with an update to the Licensing Committee, seconded by Johnny Johnson; the motion carried unanimously.

Jay Eenhuis stated the second portion of this complaint is that there are two properties that are manufactured housing, that were both occupied prior to receiving a Temporary Certificate of Occupancy or Certificate of Occupancy ("TCO or CO"). He stated RBD is authorized by the State to perform inspections on behalf of the State on manufactured housing. He stated these two homes are "permanent set" structures because they are on a permanent foundation. Mr. Reynolds stated the developer allowed the homeowners to occupy the homes, and it was against his direction and not approved by him. Mr. Eenhuis stated the permits have been completed on both homes. Mr. Reynolds stated he is working on three additional homes with this developer, and he will take the necessary steps to be certain that this does not happen again. A motion was made by Richard Gillit to place a three-year Incident Report in Mr. Reynolds' contractor file for allowing these two homes to be occupied prior to receiving a TCO or CO, seconded by Vince Colarelli; the motion carried unanimously.

b) A complaint has been brought against Tony James and Dennis Krohn, licensee for D. K. Konstruction, by Andrea Matheny for work performed at 6455 Alibi Circle, Colorado Springs, Colorado without obtaining a permit and not supervising a project for which you did pull a permit, in violation of Sections RBC201.2(6) and (7), and RBC201.11.3(3) and (5), 2011 Pikes Peak Regional Building Code.

All parties testifying were sworn in. Andrea Matheny appeared and gave the details of her complaint. She stated she signed a contract with D. K. Konstruction to reside her home, and the work was done without having a permit in place prior to commencement of the work; and the work was not done per Code or per the manufacturers' instructions. Paul Hockersmith, Krafted Homes, appeared and stated he has corrected the work that was done by D. K. Konstruction. He stated the work completed by D. K. Konstruction

was very unprofessional. Ms. Matheny stated she requested a refund of her 50 percent deposit, and compensation for damage to her roof as a result of the siding work done by D. K. Konstruction, which she has not received.

Tony James appeared and stated he was contracted to replace the siding on Andrea Matheny's home, and the permit was not pulled initially because they were pulling off the old siding and then reapplying a portion of the siding, so he did not believe a permit was required. He stated he contacted RBD staff and discovered that a permit was required, so he pulled the permit. He stated Ms. Matheny was taking pictures of the work to send to her engineer during the process which extended the projected considerably.

Dennis Krohn stated in January 2014, he sold his company to Mr. James and he works for Mr. James as an independent contractor. He stated he is a contractor/employee working for Mr. James on a "per job basis". He stated Ms. Matheny was not able to contact him, because he disconnected his land line and now uses his cell phone only. Johnny Johnson stated Mr. Krohn, as the licensee, is responsible for this project and his lack of supervision is inexcusable.

A motion was made by Johnny Johnson to place a three-year Incident Report in Dennis Krohn's contractor file, seconded by Richard Gillit; the motion **FAILED** on an 0:5 vote.

A motion was made by Vince Colarelli to place a Letter of Reprimand in Dennis Krohn's contractor file due to ordinary negligence, a permit was not obtained prior to commencement of the work, and the work was not supervised by the licensee, seconded by Johnson Johnson; the motion carried unanimously. Michael Watts, attorney for D. K. Konstruction, stated he objects to the Letter of Reprimand due to lack of notice of the complaint of ordinary negligence.

c) A complaint has been brought against Eric Rehberger, licensee for Priority Restoration, LLC, by June Park for work performed at 123 South Manitou Avenue, Manitou Springs, Colorado, without obtaining a permit, in violation of Sections RBC201.11.3(3) and (5), 2011 Pikes Peak Regional Building Code.

All parties testifying were sworn in. Eric Rehberger and Frank Rehberger appeared, and Frank Rehberger stated the insurance claim was originally approved for the full replacement of the roof, but the adjuster stated he made a mistake and reduced the amount of the claim. He stated the homeowner gave them \$10,000 of her own money to do coatings on this commercial roof, because they did not have enough money to replace the roof. He stated the homeowner is very difficult to communicate with and they were told that she has a history of not paying contractors. Mr. Rehberger stated the homeowner requested her \$10,000 back, and they had already invested \$16,000 in the project. He stated they spent \$645 on permits in addition to the \$16,000. He stated they filed a lien on the property and have filed a civil suit against the homeowner. Mr.

Rehberger stated they have been licensed since January 2014 in El Paso County. He stated they ran into permit issues with Manitou Springs. Bert Warchol stated a permit is not required for roof coatings.

A motion was made by Vince Colarelli to **DISMISS** this complaint because a permit was not required, seconded by Richard Gillit; the motion carried unanimously.

d) A complaint has been brought against David Danzl, licensee for X-Cel Restoration, Inc., by Jon Hollon for work performed at 132 Norman Drive, Colorado Springs, Colorado without obtaining a permit; and by Regional Building for performing work at 2301 Frontier Drive, 2244 Frontier Drive, and 144 Rose Drive, all in Colorado Springs, Colorado, without obtaining permits, in violation of Sections RBC201.11.3(3) and (5), 2011 Pikes Peak Regional Building Code.

This complaint has been **DISMISSED** because the complainant has **WITHDRAWN** his complaint.
