### **VARIANCE REQUESTS**

5. 4905 Juniper Valley Road, Permit J80844 – Matt Shirola, homeowner, requests a variance to Section 210.52(C)(1), 2014 National Electrical Code, to expand the distance from the kitchen sink to the electrical receptacle, where prohibited.

Matt Shirola appeared and stated this home is on their family homestead ranch, and this house was built in 1985, and is a passive solar, southwest Pueblo-style house. He stated the interior walls are stucco. He stated they are increasing the size of their kitchen to accommodate their growing family. Mr. Shirola stated they are requesting this variance so they do not have to damage the beautiful stucco walls. Dean Wemmer stated Code requires a receptacle within 24" of each side of the sink, and Mr. Shirola has 33" on one side of the sink and 52" on the other side of the sink. Mr. Shirola stated due to the construction of the wall on one side of the sink, it is not feasible to install a Code compliant receptacle on this side of the sink. Dan Rial stated this receptacle can be considered a "convenience receptacle". A motion was made by Mark Mahler to recommend to the Board of Review

6. 4907 Alteza Drive – John Davis Design Group requests a variance to the HVAC Equipment Certification, to keep the RTU's that are too large for the existing addition.
