ENERGY CODE APPROVED THIRD PARTY INSPECTIONS AND TESTING. Section R402.4.1, 2015 International Energy Conservation Code

R402.4.1.1. Installation. The components of the *building thermal envelope* as listed in Table R402.4.1.1 shall be installed in accordance with the manufacturer's instructions and the criteria listed in Table R402.4.1.1. as applicable to the method of construction. Where required by the *code official*, an *approved* third party shall inspect all components and verify compliance.

R402.4.1.2. Testing. The building or dwelling unit shall be tested and verified as having an air leakage rate not exceeding Where required by the *code official*, testing shall be conducted by an *approved* third party. A written report of the results of the test shall be signed by the party conducting the test and provided to the *code official*. Testing shall be performed at any time after creation of all penetrations of the *building thermal envelope*.

POLICY:

The following companies have been deemed to meet PPRBD's qualifications of an approved third party to perform the required inspections and testing of sections R402.4.1.1 and R402.4.1.2 of the 2015 International Energy Conservation Code.
